6. The undersigned further agrees in the event of sale or of transfer of the kit parts and specifications to notify Pro-Composites, Inc.

The undersigned further acknowledges and understands that the purchase of said kit parts, specifications and/or component parts carries with it no warranties, either expressed or implied, including warranties as to merchantability or fitness for a particular use, said warranties being specifically disclaimed by Pro-Composites, Inc.

8. The undersigned further acknowledges and understands that the responsibility for assembly and use of any aircraft assembled by the undersigned or his agents or employees is solely that of the undersigned.
